Whereby both the SELLER and BUYER agree to the terms and conditions as set out hereafter:

1. All puppies are guaranteed to be free of severe crippling defects up to one year of age. If hereditary conditions are present before one year of age, that severely lowers your puppy's quality of life, another puppy will be given to BUYER, free of charge, when available. BUYER is responsible for the shipping cost of the replacement puppy. Written verification from BUYER's veterinarian, along with his contact information is necessary. BUYER is responsible for cost of stated evaluation. Under no circumstance does SELLER grant cash refunds or accept any liability for medical expenses, veterinarian fees, or any other expenses related to the care of your puppy.
2. SELLER accepts no responsibility for any communicable diseases. Avoid exposing the puppy to public places for the first 16 weeks (4 months) of it's life and other dogs that are not in the same home to avoid health issues that could be deadly.
3. BUYER agrees female puppies will NOT be bred before 18 months of age. **If the puppy is bred, all guarantees are invalid.**
4. BUYER understands and agrees to maintain preventive care of the puppy, such as proper nutrition, exercise, and preventing stress injuries. It is the BUYER'S responsibility to research the breed for tips and recommendations on proper care and training of the breed to ensure a healthy dog.

Purchase Agreement Options

BUYER is responsible for any shipping fees and crates needed to deliver puppy safely to new home. If shipping is arranged, payment must be paid in full in cash or as arranged by SELLER's choice of payment. SELLER will hold puppy for BUYER upon receiving agreed deposit until release date agreed upon by SELLER.

If said puppy is not shipped or claimed by the agreed date, the total deposit is forfeited and the undersigned BUYER relinquishes any claim to the puppy.

Full Registration:-BUYER and SELLER agree to \$_____ deposit, remaining payment of \$_____ is due by time of pickup, which is at puppies 8 week of age or at SELLER's agreed date _____

NOTE: Puppies have full breeding rights however female puppies should NOT be bred before 18 months of age.
